#### 8. Reports from City Staff:

Senior Management Analyst Sean McGovern reported on how the new Cares Act Funding (CDBG-CV) can be spent on Public Service Grants. McGovern gave a summary of each application that was submitted in response to the solicitation of Public Service Grant proposals.

Path of Life submitted an application provide homelessness services, including the provision of a new service whereby Path of Life would secure lease agreements for apartment units in Jurupa Valley to be used as homeless shelters.

The Family Service Association submitted an application to provide sanitation kits to seniors to help mitigate the spread of COVID-19 in the City's senior population.

#### 9. Commission Business:

#### A. Funding Recommendation for CDBG-CV Public Service Grant Applicants

Senior Management Analyst Sean McGovern introduced the item to the CDAC and gave an overview of how the Public Service Grant application process works. The City has made available \$281,000.00 in Public Service Grant funds. The City received applications from Path of Life Ministries, Inc. and the Family Service Association by the application deadline of May 28, 2020. City staff recommend providing \$255,500.00 to Path of Life Ministries, Inc. to provide homelessness services and secure multiple apartment units to be used as homeless shelter. City staff recommend providing \$25,500.00 to the Family Service Association to provide sanitation kits to seniors that help mitigate the spread of COVID-19.

Leonard Jarman of Path of Life Ministries, Inc. provided a presentation to the CDAC which outlined the strategy of their proposed public service grant initiative. Vice Chair Shultz requested more specifics on the proposal to rent several market-rate apartments to be

used as homeless shelters. The CDAC deliberated the cost effectiveness of homelessness prevention vs. homelessness mitigation.

Tom Donahue of the Family Service Association provided a presentation to the CDAC which outlined the strategy of their proposed public service grant initiative.

Vice Chair Shultz moved and Committee Member Lee seconded the motion to recommend to the City Council that the Family Service Association receive a \$25,500.00 Public Service Grant award. The motion was approved 5-0.

MINISTRIES, INC. AND THE FAMILY SERVICE ASSOCIATION

#### RECOMMENDATION

1) That the Community Development Advisory Committee receive a report from City staff describing the disbursement of CDBG 2020-21 and CDBG-CV Public Service Grants, and;

2) That the Community Development Advisory Committee receive a mid-year performance report from Path of Life Ministries, Inc. and the Family Service Association

#### **BACKGROUND**

The City received a \$1,194,914.00 allocation of CDBG funds for the 2020-21 program year. Roughly 15% (\$179,237.00) of that total CDBG allocation was identified for Public Service Grant (PSG) funding. On March 9, 2020, the Community Development Advisory Committee (CDAC) finalized their PSG funding recommendations. The CDAC recommended that Path of Life Ministries, Inc. (Path of Life) be awarded \$139,237.00 for the provision of homelessness response and prevention services. The CDAC also recommended that the Family Service Association (FSA) be awarded \$40,000.00 to provide enhancements to the senior meal program delivered at the Eddie D. Smith Senior Center. Those recommendations were accepted by the City Council and agreements with both Path of Life Ministries and FSA were entered into on May 21, 2020.

In response to the COVID-19 pandemic, the Coronavirus Aid, Relief, and Economic Security ("CARES") Act on March 27, 2020 was signed into Federal law. Part of the CARES Act package included an extra "CDBG-CV" allocation for the City of Jurupa Valley in the amount of \$702,928.00. Like traditional CDBG funds, CDBG-CV funds must be spent in ways that advance the economic and housing needs of low-moderate income persons. In additional to the traditional CDBG funding requirements, CDBG-CV funds must also be spent in ways that prepare for or respond to the COVID-19 pandemic.

On June 8, 2020, the CDAC made formal funding recommendations for public service grantees utilizing CDBG-CV funds. The CDAC recommended that Path of Life receive \$255,500.00 for emergency homelessness housing and homelessness prevention. The CDAC also recommended that the FSA receive \$25,500.00 to distribute sanitation kits to at-risk senior citizens. These funding recommendations were approved by the City Council on June 4, 2020.

The table below provides a visual illustration of the funding that Path of Life and FSA received from both the CDBG 2020-21 budget and the CDBG-CV budget.

#### **ANALYSIS**

To assist the CDAC in monitoring the performance of public service grant recipients, City staff have asked Path of Life and FSA to prepare oral presentations for the November 9, 2020 meeting. The CDAC will have the opportunity to ask specific, performance-related questions of each PSG recipient.

#### Path of Life Activities:

Path of Life received both CDBG 2020-21 and CDBG-CV funds. Recently, significant COVID-19-related changes were made to Path of Life's shelter intake process. A "pause" on the shelter intake process has been initiated to mitigate the spread of COVID-19 after a shelter guest tested positive. Other than those changes, the CDBG 2020-21 programming for Path of Life is moving routinely at a steady pace.

Path of Life has faced significant difficulty in securing two market-rate rental apartments to be used as segregated homeless shelters. Identified in Path of Life's CDBG-CV public service grant, the purpose of the rental apartments is to allow for a safer segregation of

shelter guests by prioritizing the occupancy of at-risk individuals. Despite COVID-19, the rental market for one and two bedroom apartments in Jurupa Valley remains extremely tight. The perpetually low inventory of available apartment units has delayed Path of Life's implementation of this program.

As of October 1, 2020, the homelessness prevention component of Path of Life's CDBG-CV allocation remains well funded. Path of Life's CDBG-CV grant included an additional \$117,069.00 to be used for short term rental, utility, and emergency assistance. As of October 1, 2020, only \$12,790.00 has been exhausted. This is likely due to the local eviction and utility shut off moratoriums. Once these moratoriums are lifted, we expect these funds to be depleted rather quickly.

#### Family Service Association Activities:

1 Provide alternate direction to City staff

To date, the FSA has not submitted official reimbursement requests to the City for either the CDBG 2020-21 or CDBG-CV funds, but this is not unusual. The senior meal program (funded with CDBG 2020-21 funds) has changed to a curbside service. The Jurupa Area Recreation and Park District (JARPD) now manages the day-to-day operations of the Eddie D. Smith Senior Center. FSA and the JARPD have a positive working relationship and are implementing plans to distribute sanitation kits to seniors as a component of the curbside meal service program.

#### FINANCIAL IMPACT

Public service grant allocations are derived from the City's CDBG 2020-21 and CDBG-CV allocations. No impact to the City's General Fund.
